- 10. Groundwater Sustainability Activities Review for Possible Action
 - 10.1 Sustainable Groundwater Management Act (SGMA) Update
 - 10.1.1 Allocating Overdraft and Quantify Outflows in the Kings Subbasin Chad Wegley reported that Provost & Prichard (P&P) is estimating overdraft for the entire Kings subbasin and developing a methodology for prorating overdraft to each GSA. He also reported that North Fork Kings GSA is administering this grant and that the \$1.5 million awarded to the subbasin will be split equally 7 ways; each GSA will receive about \$214,000.
 - 10.1.2 <u>Water Budget</u> Chad Wegley explained that the water budget is a key coordinated activity for the subbasin and as such Provost & Pritchard will provide the GSA will a proposal for this effort. s

- 10.1.3 <u>Prop 26 Invoices</u> GSA invoices went out this week. As of today, the KREGSA has received payment from one landowner.
- 10.2 DWR / SWRCB Activities
 - 10.2.1 <u>Best Management Practices</u> Chad Wegley reported no major changes on the BMPs.
 - 10.2.2 <u>Basin Boundary Modifications and Update to the Basin Designations</u> Chad Wegley reported that the application deadline for submitting a basin boundary modification application to DWR is June 30, 2018. No action was taken on this issue.
 - 10.2.3 <u>SWRCB Prop 1 Groundwater Grant Program</u> Chad Wegley explained that 4Creeks was reviewing the Round 2 grant program to see if the GSA might have an eligible project. More information about this program will be available at a future meeting.
- 11. Legal Issues Review for Possible Action
 - 11.1 <u>Attorney Legal Update</u> Attorney Layne provided the Board with a synopsis of Assembly Bill (AB) 1668, AB 3030 and Senate Bill (SB) 606. Collectively, these bills address various issues such as standards for water use efficiency, streamline CEQA, and expand water management planning requirement for urban water suppliers.
 - 11.2 <u>Kings Subbasin Coordination Agreement</u> It was **M/S/C unanimously by Brandt / Paxton** to execute a Memorandum of Understanding (MOU) among GSAs in the Kings Subbasin regarding grant funds sharing and dispute resolution.
