

**RESOLUTION 2019-02-01  
MISCELLANEOUS FEE SCHEDULE**

**BEFORE THE BOARD OF DIRECTORS  
OF  
KINGS RIVER EAST GROUNDWATER SUSTAINABILITY AGENCY**

- A. **WHEREAS**, Senate Bill 37, now known as the Kings River East Groundwater Sustainability Act (the “Act”), was passed and signed into law by Governor Jerry Brown and became effective on January 1, 2017; and
- B. **WHEREAS**, the Act created a special act district, the Kings River East Groundwater Sustainability Agency (“KREGSA”), to serve as a GSA, pursuant to the Sustainable Groundwater Management Act (“SGMA”), within the Kings Subbasin; and
- C. **WHEREAS**, KREGSA does not have a formally adopted fee schedule to recover various miscellaneous expenses related to KREGSA services; and
- D. **WHEREAS**, KREGSA desires to adopt a miscellaneous fee schedule to recover the costs incurred by KREGSA for collecting late payments, returned checks, and credit card charges associated with the payment of KREGSA Proposition 26 fees for GSP development.

**NOW THEREFORE, BE IT RESOLVED** by the Board of Directors of the Kings River East Groundwater Sustainability Agency as follows:


1. The Board of Directors (“Board”) hereby finds and declares that the above Recitals are deemed true and correct and are incorporated herein by this reference.
2. It is prudent and necessary for KREGSA to recover expenses related to various customer services through adoption of a miscellaneous fee schedule.
3. KREGSA’s Board hereby adopts the “Miscellaneous Fee Schedule” attached hereto as Exhibit “A” and incorporated herein by this reference.
4. The Board hereby finds and determines that this Resolution shall be effective upon its approval and adoption.
